#### Increasing AREA Annual Dues from \$10 to \$25

AREA's annual dues for membership are only \$10 a year. The revenue generated from the dues supported the educational program at the ISA Annual Conference and Trade Show. For the longest time, this was the main purpose to AREA. Now is the time to do more. Many new opportunities exist to encourage communication and coordination among scientists and educators working in arboriculture and urban forestry through physical, biological, ecological and the sociological sciences.

Only recently did other outreach programs begin to appear. The quarterly electronic newsletter and the AREA website area.isa-arbor.com now are available to members. To encourage and enable future growth administrative assistance is needed. ISA voluntarily supported our efforts in the past and now the workload is beyond volunteer time commitments and priorities.

The newsletter and website, though very cost effective, still require time to produce and maintain. With new strategic opportunities, AREA will need to invest additional time and capital. The best way to meet our existing service requirements and future growth is to increase AREA dues from \$10 to \$25.

In the overall scheme of other groups vying for membership dollars, \$25 is a bargain. Other ISA professional affiliations annual dues are \$25 (UAA), \$35 (SCA), and \$75 (SMA). Chapter dues range from \$30 to over \$100. Most are in the \$40 to \$50 range. From a price perspective, AREA is very competitive. From a member value perspective, AREA has plenty of room for growth. Take the UAA as a comparably priced membership. They send out a 40 page, four-color magazine every quarter, provide money for grant projects, organize six regional conferences, and other with a paid half-time administrative coordinator and part-time Executive Director.

ISA's Science and Research Manager, Steve Bevil, is only available from ISA for another year only as a volunteer. After that, AREA will need to pay for administrative services. All other ISA Professional Affiliations contract with ISA for some level of services. Administrative economies of scale and association expertise are primary reasons for contracting with ISA. The estimated costs for coordinator services for AREA is around \$23.58/hr. For web site programming requiring an IT person the price is about \$32.75 an hour. If we need an executive director level, it is \$58.95.

Having consistent administrative services opens huge growth opportunities for AREA. AREA can consider upgrading and maximizing the AREA web site so it becomes a premier informational resource for researchers and educators. Job announcements in academia, research, and industry could be posted on the AREA web site in addition to advertisement of graduate student assistantships and fellowships. Other sources of information to include on the web site are: posting of research abstracts presented at ISA conference, database of the AREA members and what area of expertise they have (either research or educational area), database of all educators at two and four-year colleges that offer either arboriculture, urban forestry, or ornamental horticulture, etc. The Science and Research Manager works closely with the AREA President to develop four AREA email newsletters each year.

Another reason for the proposed increase in AREA membership dues are the student travel awards. AREA would like to continue to offer graduate student travel awards for

### SAC Takes Action to Boost Student Membership

The ISA Student Activities Committee met at the Morton Arboretum June 12-14, 2007 to develop their 2007-08 plan of work. Participants emphasized the importance of recruiting new ISA members during their college years and serving as a bridge between these students and potential employers. With these goals in mind, the committee is seeking "student champions" within each chapter. The champions will work on behalf of the arboriculture students in their area and involve them in chapter activities. Interested ISA members should contact Dr. Harvey Holt at holth@purdue.edu.

In addition, the committee is developing recruitment posters, how-to packets for chapters and club advisors, and regional student events. Chapters interested in partnering with SAC on a student event are encouraged to contact the committee.

In the long term, SAC recognizes the need to market arboricultural careers at the K-12 level. Committee members are developing a K-12 "outreach toolbox" that arborists can use to make presentations at their local schools. Through these and other activities, SAC aims to double student membership within the next three years and to retain former student members as enthusiastic professional members of ISA.

their oral presentations. In addition, we would like to extend this travel award to student poster presenters, but at this time, we do not have the money in the budget.

In addition, travel by the Past-President to attend two ISA Board of Directors meetings will need to be partially or fully funded by AREA. In the past, the AREA President has received partial reimbursement for their travel to attend the ISA Annual Conference and AREA Business Meeting. This is vital to stay connected with the dramatic growth of ISA. Many of us in academia do not have travel expense account and all of our travel either must come out of existing grants, if allowed, or our own pockets. Coverage of these two officers travel is a benefit of their continued service to AREA.

AREA would also like to prepare a membership application brochure to recruit new members. Currently, AREA does not have one. This 3-fold, colored brochure would be available at the ISA Annual Conference and other events and would serve as a good recruiting tool for new AREA members. In the brochure, we would list the benefits of becoming an AREA member.

Finally, with the increased cost of planning the AREA business meeting at the ISA Conference, AREA will need to partially subsidize the expenses to cover all the costs. The expenses are partially covered by ticket fees though the variability of venues can bring an inconsistency to expenses. To encourage the participation of attendees AREA partially subsidizes meeting expenses. This meeting acts as the primary strategic planning vehicle for AREA because of the connection to the arboricultural experts attending the conference.

Therefore, I would like to propose AREA Annual Membership dues be increased from the current \$10/year to \$25/year. We are open for discussion at the AREA Annual Business meeting and will vote on this manner at that time.

### AREA Budget for Fiscal Year July 1, 2007-June 30, 2008

#### **AREA Budget: Expenses**

**Travel: \$4,000** (more this year due to location of conference) (last year expenses were \$2000)

- -Past President's (AREA representative) travel to attend two ISA Board of Directors meetings (Hawaii and other location to be determined in 2008)
- -President's travel to attend ISA Annual Conference and AREA Business meeting

**Student Awards: \$3,500** (last year expenses were \$2250 for student competition)

-Travel awards for all graduate students who are presenting their research orally during the AREA professional affiliation day at the ISA Conference. At this time, we do not have enough to cover both poster and oral presenters

**AREA Luncheon:** \$400 (two years ago, we spent \$203.86 to cover the costs above what we got in registration)

-Subsidize the AREA Annual Business Meeting Luncheon for charges not taken care of through registration for the luncheon. This is new this year as what we are charging for lunch (\$35/person) is not enough to cover all the costs of the lunch service.

### Annual Planning Session Held at Headquarters

Members of the ISA
Executive Committee, committee chairs, and ISA staff came together May 4–5 to plan for the upcoming fiscal year. Participants utilized small group discussions to review and update the ISA
Strategic Plan as well as an exercise working through a priority process for future ISA projects and products.

The weekend concluded with a review of the ISA 2007–08 proposed budget.

### Records Were Made to be Broken

Thanks to a few hundred dedicated volunteers and a hard working, dedicated staff, the ISA Certification program continues to surge to new heights. Last month, ISA broke the 20,000 ISA Certified Arborist plateau.

ISA has passed its last year's record total of 3,000 applications, and now has hit a recertification rate of over 90 percent, for those whose certification expired in December.

ISA strives to make it a worthwhile investment of time and money to everyone who has an ISA credential.

#### **AREA purchase insurance through ISA: \$500** (last year expense was \$459.60)

-Required for us to purchase this insurance

#### AREA checking account fees (checks) and office supplies: \$50 (last year we spent \$20) for checks)

-Need to cover costs of ordering checks and miscellaneous office supplies (stamps, envelopes, etc.)

#### Total Budgeted Expenses for AREA for next year: \$8,450 (last year was \$5190)

Expenses are more this year due to seven graduate student travel awards and increased costs for officer travel to attend conference and ISA Board of Directors meeting in Hawaii.

#### **AREA Budget: Income**

AREA's sole revenue is from AREA annual membership dues collected by ISA: estimate at \$6,000 (last year income generated from dues was \$6,028.25)
